

**ARTICLES OF ORGANIZATION
OF
DIGITAL ECHO, LLC**

A Florida Limited Liability Company

The undersigned hereby acknowledges these Articles of Organization for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, Chapter 608, Laws of Florida.

**ARTICLE I
Name**

The name of the Limited Liability Company is Digital Echo, LLC.

**ARTICLE II
Address**

The address of the principal office of the Limited Liability Company shall be 1002 South Old Dixie Highway, Suite 104, Jupiter, Florida 33458.

**ARTICLE III
Registered Agent and Registered Office**

ARTICLE VI
Commencement

The Limited Liability Company shall commence its existence upon filing with the Secretary of State of the State of Florida.


