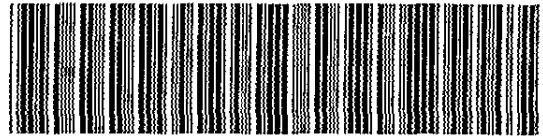



**ARTICLES OF ORGANIZATION  
OF

**ARTICLE I  
NAME**

The name, address and principal place of business of the limited liability company is:
