**ARTICLE I  
NAME**

The name of the Limited Liability Company is Willcorp., LLC.

**ARTICLE II  
ADDRESS**

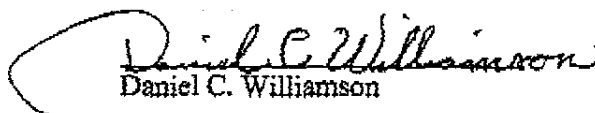
