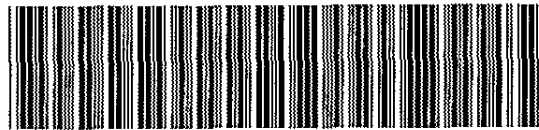

OF


