The mailing address and street address of the principal office of the Company is 15751 Sheridan Street, Suite 187, Fort Lauderdale, Florida 33331.

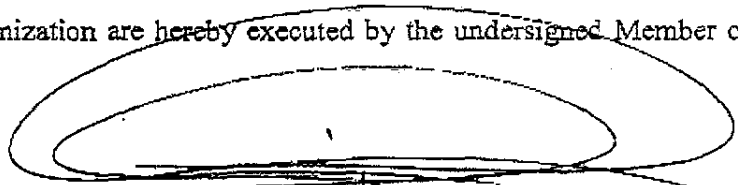
ARTICLE III - Registered Agent

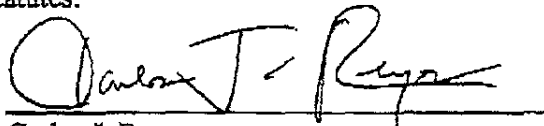
