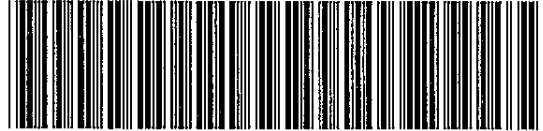

**ARTICLES OF ORGANIZATION
FOR

A Florida Limited Liability Company
