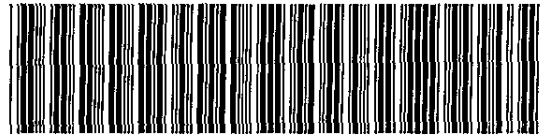

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **TTA CONSULTING, LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 1840 Coral Way, Fourth Floor, Miami, Florida 33145 and the mailing address shall be Paseo Maritimo 37, 11 H, Palma de Mallorca, Spain 07014.

ARTICLE 3 - EFFECTIVE DATE




