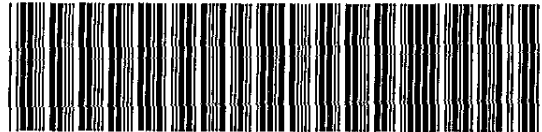

**ARTICLES OF ORGANIZATION  
OF  
KEVIN J. THOMAS, LC**

THE UNDERSIGNED hereby certifies that he intends to form a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. I further declare the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

**ARTICLE I  
NAME**

#### **ARTICLE IV DURATION**

The duration for the Company shall be thirty (30) years, unless terminated sooner by operation of law, by agreement of the members of reinacted after such primary term for such additional period as is mutually determined by the members.

#### **ARTICLE V MEMBERS**

There shall be two (2) classes of members, namely:

1. Class A Members- Class A Members shall have voting rights.
2. Class B Members- Class B Members shall have no voting rights.

#### **ARTICLE VI REGISTERED AGENT AND OFFICE**

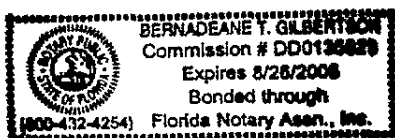
