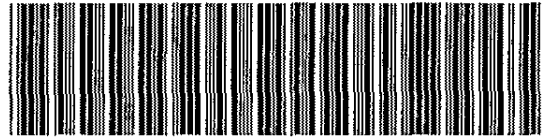

ARTICLE 1 - NAME

The name of the limited liability company shall be **BPK TRADERS, L.L.C.**, ("Company").




