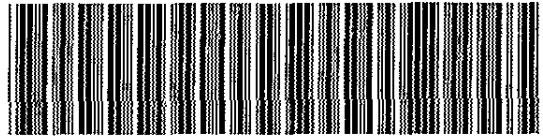

**ARTICLE OF ORGANIZATION

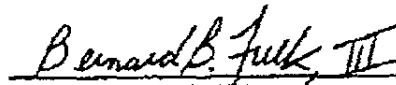
