The period of duration for the Limited Liability Company shall be: perpetual.

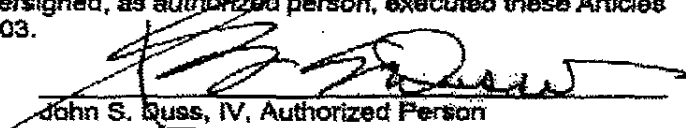
ARTICLE 4.: MANAGEMENT

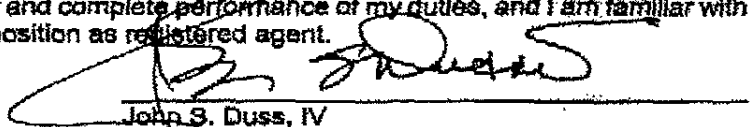
