
Pursuant to Section 608.411 of the Florida Limited Liability Company Act, the undersigned, who are all the members of TRINITY PLACE, LLC, hereby amend the Articles of Organization of the limited liability company originally filed with the Secretary of State of the State of Florida on April 07, 2003, and amended by Amendment to Articles of Organization filed March 26, 2004, as follows:

1. Amend ARTICLE I to read as follows:

The name of the Limited Liability Company is: TRINITY TOWN CENTER, LLC

2. The articles of organization for the company were originally filed under the name Covington Quality Property, LLC on April 07, 2003. The Amendment filed March 26, 2004, changed the corporate name to Trinity Place, LLC. The remainder of the provisions of the Articles of Organization, as previously filed, shall remain.
