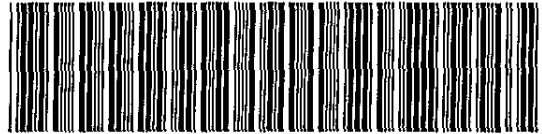



ARTICLES OF ORGANIZATION
OF
SCUPA'S ENTERPRISES, L.L.C.
A Florida Limited Liability Company

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company:

1. Name. The name of this company shall be SCUPA'S ENTERPRISES, L.L.C.
2. The mailing address is P.O. Box 940446, Maitland, FL 32794, and the street address is 2275 King Edwards Ct., Winter Park, FL 32792.
3. Registered Agent and Office. The name and street address of the initial registered agent and office for this company is as follows: John N. Livera, 2275 King Edwards Court, Winter Park, FL 32792.
4. Admission of Additional Members; and Terms and Conditions of such Admissions: Additional Members may be admitted upon the approval of a majority of the Members of the Company.
5. Right to Continue Business.

The remaining members may continue the Business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member of the occurrence of any other event which terminates the continued membership of a member in the company.

6. Management of Company.

This limited liability company is to be a "Manager Managed Company"


7. Amendment of Articles of Organization. The power to adopt, alter, amend or repeal the regulations of the limited liability company shall be vested in the Members unless vested in the Manager(s) of the company by any amendments of the Articles of Organization. Regulations adopted by the Members or by the Manager(s) may be repealed or altered, new Regulations may be adopted by the Members, and the Members may prescribe in any Regulations made by them that such Regulations may not be altered, amended or repealed by the Manager(s).
