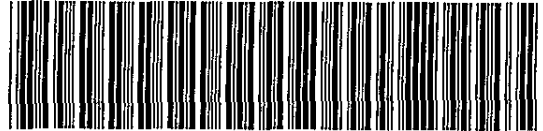



The net assets of the corporation remaining after winding up, if any, have been distributed to the members.


