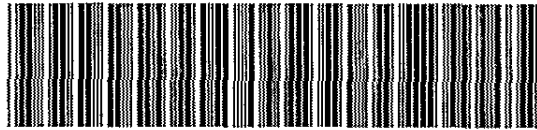





1. **Name.** The name of this limited liability company is LINEBACK WINES, LLC ("Company").
2. **Duration.** The Company shall exist from the date of filing of these Articles of Organization with the Department of State until the earlier of 30 years from the date of filing or the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.
3. **Purpose.** The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the law of Florida, including but not limited to the production and manufacturing of wine, wine sales, the management of wineries, wine events, the formation of wine clubs and the research and development and retail of fermented beverages.
4. **Registered Agent and Office.** The name of the initial registered agent of the Company is Franz Streinesberger. The street address of the initial registered agent of the Company is 168 Mangrove Bay Court, #203, Ocoee, Florida 34761.
5. **Principal Place of Business.** The mailing address and the street address of the Company's principal place of business is 316 Duncan Court, Orlando, Florida 32835.
6. **Additional Members.** Additional members to the Company may be admitted, but only upon a majority consent of all current members.
7. **Management of the Company.** The Company shall be managed by managers in accordance with the regulations and operating agreement. The Company shall initially be managed by the following three persons who shall serve as managers until the first annual meeting of the members or until their successors are elected and qualified:

Don Lineback, Ed Gogel and Franz Streinesberger
8. **Regulations.** The members shall have the power to adopt, alter, amend, or repeal regulations of the Company containing provisions for the regulation and management of the affairs of the Company.
9. **Certificated Interests.** The members' interests in the Company shall be evidenced by certificates.


