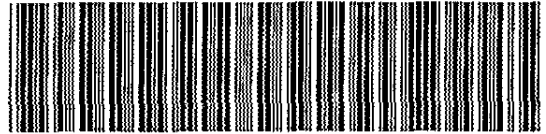


**ARTICLE IV


