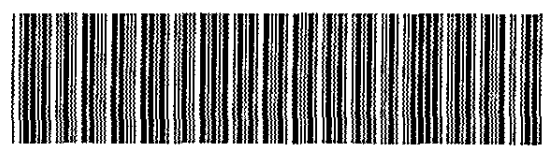

**ARTICLES OF ORGANIZATION
OF
OLD MOULTRIE CROSSING, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I
NAME AND ADDRESS**

The name of the limited liability company shall be OLD MOULTRIE CROSSING, LLC ("Company"). DURATION**




