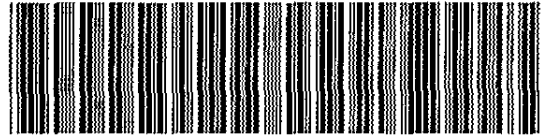

The mailing address and street address of the principal office of the company shall be 1328 Carlton Court, #101, Fort Pierce, Florida 34949.


ARTICLE III-REGISTERED OFFICE AND AGENT


