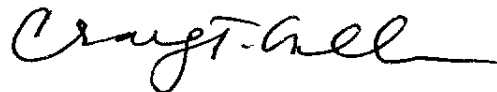

**ARTICLE V – EFFECTIVE DATE**

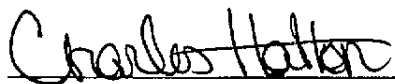
