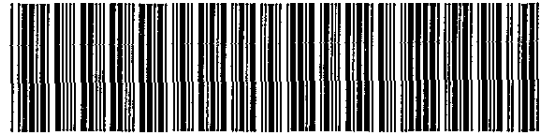

The Company shall exist perpetually, unless sooner dissolved in accordance with the Company's Operating Agreement or Florida law.

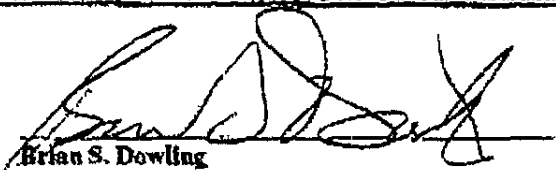
ARTICLE IV - Registered Agent and Office

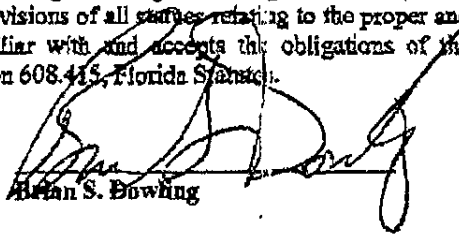
