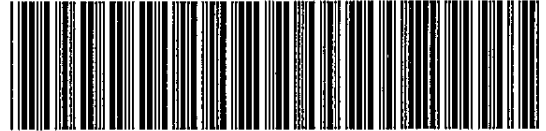

- SECOND:** The following amendment to the articles of organization was adopted by the limited liability company:


ARTICLE I

All other provisions of the Articles of Organization as originally filed remain in effect.


