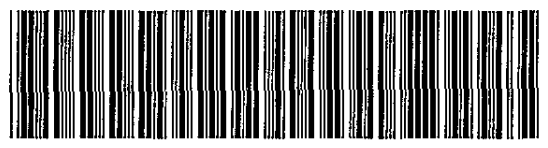

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

### ARTICLE 1 - NAME

The name of the limited liability company shall be **PARIS NAILS LLC**, ("Company").

### ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 4510 Northwest 183rd Street, Miami, Florida 33055 and the mailing address shall be the same.


