ARTICLES OF ORGANIZATION OF 27 PROJECTS, LLC

ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this limited liability company shall be 27 PROJECTS, LLC, and the mailing address of its principal office shall be P.O. Box 510716, Punta Gorda, Florida 33951-0716, and the street address of its principal office shall be 265 Bangsberg Road, Port Charlotte, Florida 33952, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE II

PURPOSES AND POWERS

MEMBERSHIP RESTRICTIONS
