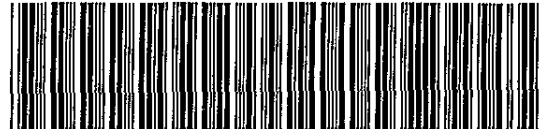

5. The purpose of the Company is to engage in any activity or business permitted under the laws of the United States or of the State of Florida.


