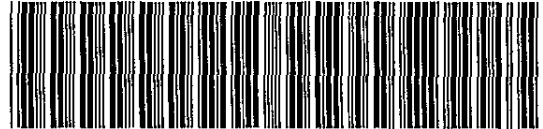

Amendment of shares distribution is as follows:

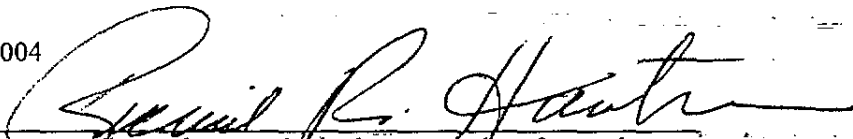

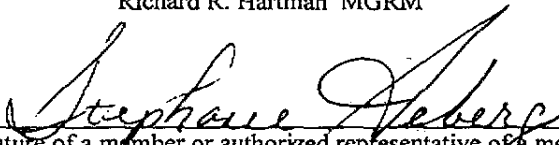
THIRD: i-can.net, inc. will be a Managing Member of said LLC.

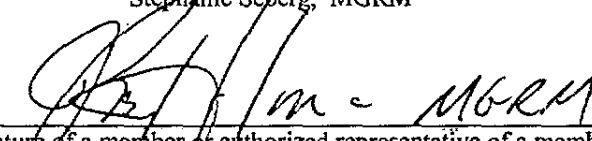
