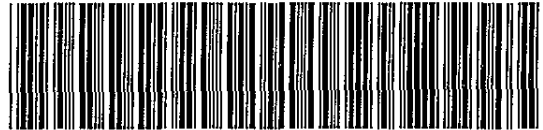

ARTICLE V -- MANAGEMENT




