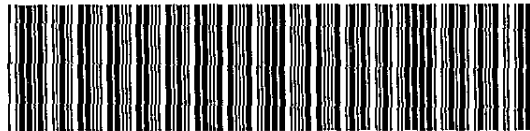



ARTICLES OF ORGANIZATION OF
POLTORACK, SHAFRAN & FALZONE LLC

(NAME CHANGE TO POLTORACK,

ARTICLE I – NAME

The name of the limited liability company is hereby changed from Poltorack, Shafran & Falzone LLC to Poltorack, Shafran, Falzone & Shein LLC.


