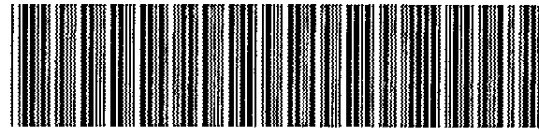

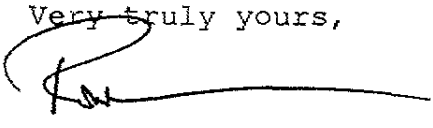

ARTICLES OF ORGANIZATION OF

ARTICLE I – NAME

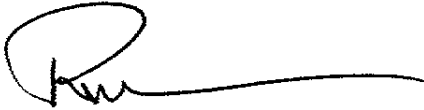

The Members of the Company shall have the sole and exclusive power to adopt, alter, amend, restate or terminate the Operating Agreement.

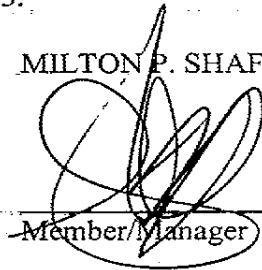
