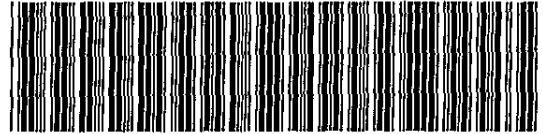

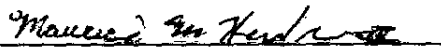
Dear Florida Division of Corporation,
