

**ARTICLES OF ORGANIZATION FOR
GRAND ROUNDS PHYSICIAN PLACEMENT, L.L.C.,
a FLORIDA LIMITED LIABILITY COMPANY**

The undersigned member or authorized representative of a member pursuant to Chapter 608 of the Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such Limited Liability Company:

ARTICLE I - Name:

The name of the Limited Liability Company is GRAND ROUNDS PHYSICIAN PLACEMENT, L.L.C.

ARTICLE II - Address:

The mailing address and street address of the principal office of the Limited Liability Company is 140 East Rockwood Way, Winter Park, Florida 32789.
