MEMBERSHIP

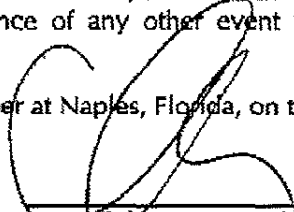

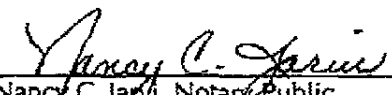
