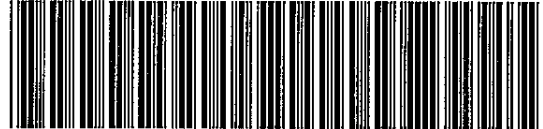

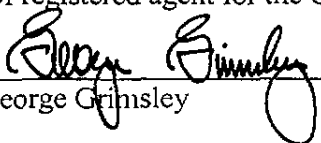
ARTICLE I. NAME: The name of the limited liability company (the "Company") is: Powell 98 LLC.

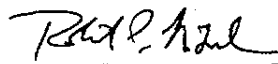
