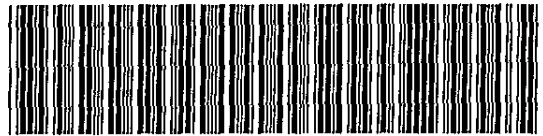

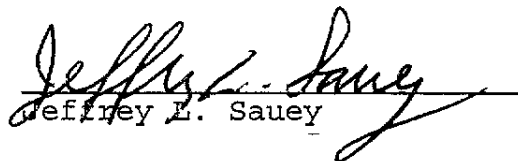

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that
TALLAHASSEE, FLORIDA

ARTICLE I - Name

The name of the limited liability company (hereinafter referred to as the "Company") is "BLBJ, LLC."

ARTICLE II - Address

The mailing address and street address of the principal office of the Company is 3380 South East Lake Weir Road, Suite B, Ocala, Florida 34471.

ARTICLE III - Duration

The period of duration for the Company shall be perpetual.

ARTICLE IV - DESIGNATION OF REGISTERED AGENT
