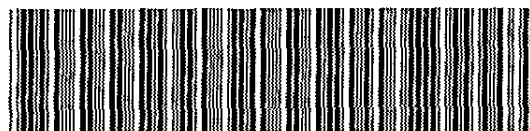

ARTICLES OF ORGANIZATION

A LIMITED LIABILITY COMPANY

(Pursuant to s. 607.407, Florida Statutes)

1. Name. The name of the limited liability company is Capital W., LLC.


