ARTICLES OF ORGANIZATION

OF

CAIR CORD AND INC OKEECHOBEE AVIATION AND DEVELOPMENT

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be OKEECHOBEE AVIATION AND DEVELOPMENT LLC, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 10108 441 Southeast, Okeechobee, Florida 34974 and the mailing address shall be 1100 Southeast 5th Court, Suite #49, Pompano Beach, Florida 33060.

ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

All references in these Articles of Organization to "manager", "officer", "employee" and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons.
