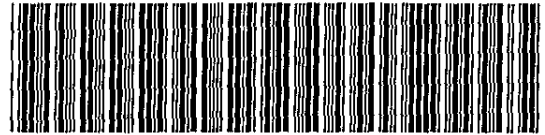

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and certifies the following Articles of Organization.

ARTICLE I - Name

The name of the limited liability company shall be: **Domingos Enterprises, LLC**

ARTICLE II - Address

The principal place of business of the company in Florida shall be 4803 Laddie Ct., Orlando, FL 32821 and the mailing address shall be the same.

ARTICLE III - Effective Date
