ARTICLE I
NAME, PRINCIPAL ADDRESS, AND MAILING ADDRESS

The name of this limited liability company is Service 1st Title Insurance Agency LLC and the initial principal address and mailing address of the limited liability company is 1299 Main Street, Suite I, Dunedin, Florida 34698.

ARTICLE II
NATURE OF BUSINESS AND POWERS



MANAGEMENT



