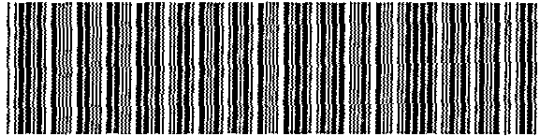



The mailing address and the street address of the principal office of the Company is 499 Sheridan Street, Dania, Florida 33004.




