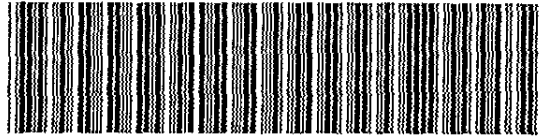



Address




