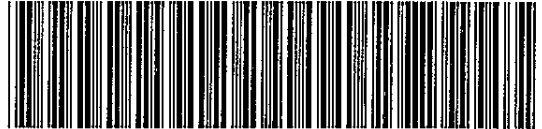

ARTICLE THREE

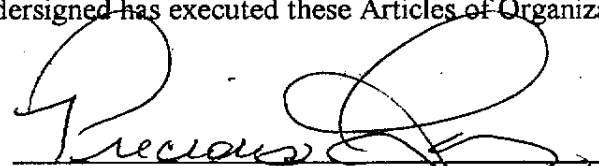
