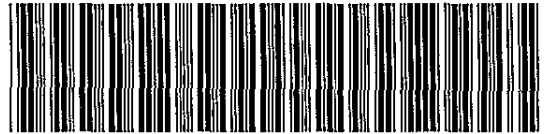


1. The name of this limited liability company is ADVANCED PROSTHETICS OF FLORIDA, LLC.
