#### ARTICLES OF ORGANIZATION

#### **OF**

## CUSTOMER DIRECT TRANSPORTATION, LLC

The Articles of Organization following are adopted for the purpose of organizing a Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

#### ARTICLE I

Name and Address of Company

Commencement and Duration of Company

#### ARTICLE VII

# Operating Agreement and Regulations
