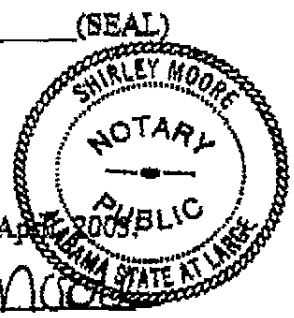
ARTICLE IV Registered Office and Agent
