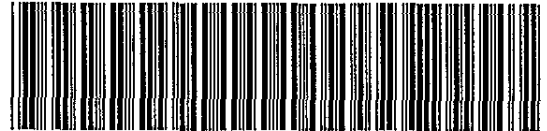

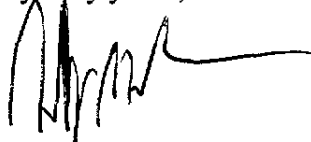

MEMBERS' RIGHTS TO CONTINUE BUSINESS**

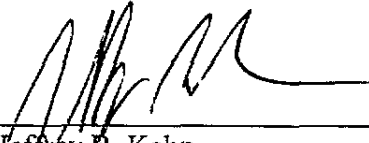

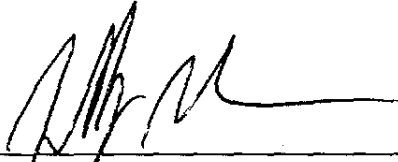
