

## ARTICLE. 1 NAME

The name of this limited Liability Company is **MELETTI ACQUISITIONS. L.C.** 

### ARTICLE II-DURATION

This limited Liability Company shall begin its existence commencing on the date of the filing of these articles with the Department of State and shall be perpetual in duration.
