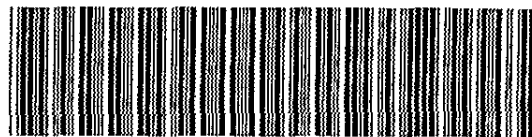



ARTICLE. 1 NAME

The name of this limited Liability Company is MELETTI ACQUISITIONS,
