ARTICLES OF ORGANIZATION

OF

WRIGHT CONSULTING, L.L.C.

The undersigned persons, acting as the organizers of **WRIGHT CONSULTING**, L.L.C., (The "Company") under the Florida Limited Liability Company Act, Chapter 608, <u>Florida Statutes</u>, adopt the following Articles of Organization:

ARTICLE I. NAME AND ADDRESS

The name and mailing and principal address of the Company is: **WRIGHT CONSULTING**, **L.L.C.**, located at 24780 Pennyroyal Drive, Bonita Springs, Florida 34134.

ARTICLE II. COMMENCEMENT AND DURATION OF EXISTENCE
