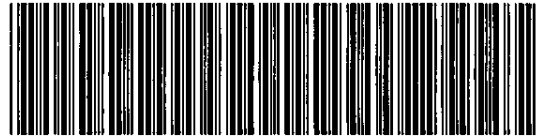

WHEREAS, the Articles of Organization of KB PARKSIDE, LLC (the "Company") were filed with the Florida Department of State on April 25, 2003 as Document L03000014947; and

WHEREAS, it is the intention of the Members of the Company that the Articles of Organization of the Company be amended, effective the date this Amendment is filed with the Florida Department of State, in accordance with the proposed amendment hereinafter set forth; and

WHEREAS, the proposed amendment to the Articles of Organization of the Company as hereinafter set forth was approved by written action of the Members, pursuant to the provisions of Sections 608.411 and 608.4231(4) of the Florida Limited Liability Company Act on the 6th day of December, 2006.

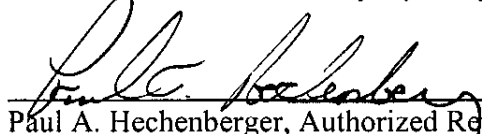
NOW, THEREFORE, the Articles of Organization of the Company are hereby amended effective the date this Amendment is filed with the Florida Department of State, as follows:

1. Article IV is deleted in its entirety and the following is substituted therefore:

**ARTICLE V – Purpose**

The sole purpose of the Limited Liability Company shall be to (a) own, hold, sell, transfer, exchange and operate the real property known as "The Shoppes at Park Place" (the "Property"); and (b) borrow under and give security for that certain loan regarding the Property (the "Loan") pursuant to its terms and to perform all acts permitted under the Loan; and (c) to transact any and all lawful business for which a limited liability company may be organized under the laws of the State of Florida that is incident, necessary and appropriate to accomplish V(a) and (b). The Limited Liability Company shall not engage in any other business nor own any assets other than that delineated in V(a), (b) and (c).

IN WITNESS WHEREOF, this Amendment to Articles of Organization is hereby executed on behalf of the Company by Paul A. Hechenberger, an Authorized Representative of the Members of the Company this 6th day of December, 2006.
