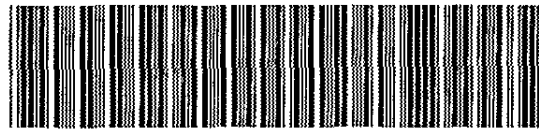

### **ARTICLE I - Name**
