ARTICLES OF ORGANIZATION

OF

PURELY LINTERS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company is **PURELY LINTERS, LLC** (the "Company").

The mailing address and street address of the principal office of the Company is 901 Douglas Avenue, Suite 101, Altamonte Springs, FL 32714.

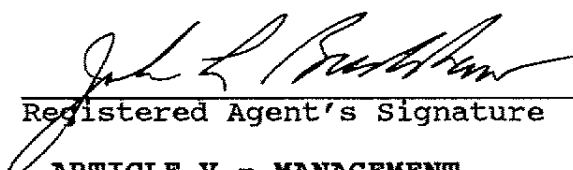
ARTICLE III - DURATION

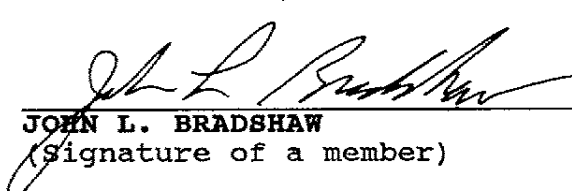
ARTICLE VI - INCOME TAX TREATMENT
